

ORDINANCE 2022-01

AN ORDINANCE TO AMEND SECTION 2-55 OF THE CODE OF ORDINANCES FOR THE CITY OF BARNWELL SECTION (a)(6) TO ADD TOURISM SO THAT WHEN AMENDED SHALL READ PARKS, RECREATION AND TOURISM; TO DELETE IN ITS ENTIRETY SECTION (a)(8); TO AMEND SECTION 2-55(d) OF THE CODE OF ORDINANCES FOR THE CITY OF BARNWELL SO AS TO DELETE MAYOR AND HIS AND BY ADDING ALONG WITH COUNCIL SO THAT WHEN AMENDED SHALL READ AS FOLLOWS: THE MAYOR ALONG WITH COUNCIL ARE FURTHER AUTHORIZED TO APPOINT SPECIAL COMMITTEES TO BE MADE UP OF PERSONS WITHIN OR WITHOUT THE CITY GOVERNMENT AS IN THE MAYOR'S ALONG WITH COUNCIL'S JUDGMENT MAY BE NEEDED

Be it ordained by the Mayor and Council of the City of Barnwell, South Carolina as follows:

WHEREAS, when amended Sec. 2-55, Council Committees shall read as follows:

Sec. 2-55. Council committees.

(a) To better facilitate the operation of city government, the mayor shall, as soon after the beginning of each term of office as possible, appoint members of council to the following standing committees:

- (1) Fire;
- (2) Police;
- (3) Finance and salary;
- (4) Sanitation and streets;
- (5) Parks, Recreation & Tourism
- (6) Water and sewer;
- (7) Building and planning;

Membership on the Finance and Salary committee shall change annually.

(b) The following committees shall be appointed by the members of council:


- (1) Building appeals board;
- (2) Planning commission;

- (3) Board of zoning appeals; and
- (4) Recreation.
- (c) Each committee shall have the responsibility to investigate and make recommendations to council concerning the matters within that committee's areas of responsibility. The area of responsibility of each committee shall be as determined by council at the beginning of each term.
- (d) The Mayor along with Council are further authorized to appoint special committees to be made up of persons within or without the city government as in the Mayor's along with Council's judgment may be needed.






